When purchasing pre-recorded workshops, participants will need to create an account using their email address and password. Participants must complete the form with the same email address that was used in creating the account to ensure credit is received for the course. Please ensure you enter your legal name as this will be the information printed on the Certificate of Completion.

Certificates will be sent to the email provided during the sign-up process. Participants will be required to submit the certificate to their licensing board.
